BUSINESS:

1.) Official Swearing-in of all Beautification Committee Members by City Clerk Gabriela Garcia:

All members present raised their right hand and were asked to repeat after the City Clerk who recited the City of Calexico, County of Imperial Oath or Affirmation of Allegiance for Public Officers and Employees. After being officially sworn in, they were all given their certificate.

2.) Beautification Committee Attendance Report – Jan. to June 2015:

City Clerk, Gabriela Garcia, went over Chapter 2.19.020 – Vacancies and Removal of Members of Ordinance 1159 specifically Sections B and C. These sections address absences from committee members. She advised that an attendance report would be presented as an informational item at every meeting to keep everyone informed.

3.) AB 1234 Ethics Training for Beautification Committee Members:

City Clerk, Gabriela Garcia, explained to the members present that the City Council had ordained that all members of a commission, board or committee take the mandatory training. She further explained this training was two hours long. She gave the website address so they could take it from the comfort of their home or they could use the City Clerk's office to come and take the training there. The deadline for taking this training is within the next two weeks.

4.) Public Signing of the City of Calexico Code of Ethics by the Beautification Committee Members:

City Clerk, Gabriela Garcia, advised all members present that on February 3, 2015, the Calexico City Council unanimously approved Resolution No. 2015-08, adopting a Code of Ethics for the members of the City Council and for the members of all Boards, Committees and Commissions appointed by the City Council. On February 17, 2015, the City Council publicly signed the Code of Ethics and requires that all Commissions, Boards and Committees does the same. Ms. Garcia assigned a section of the Code of Ethics to be read out loud by each member present. After the entire Code of Ethics was read out loud by all members present, they all signed it and turned it in to the City Clerk.

5.) Discussion – Cleaning of All Entry-ways to the City of Calexico:

Mr. Servin, Public Works Director/City Engineer, advised City needs permission from Cal-Trans to clean the entry-ways to the City due to them being in State Highway jurisdiction. He informed everyone there that the State has an Adopt-A-Highway Program that they could apply for and get in as a group and plan clean up days to maintain those areas of concern. He offered to bring back more information on this program to the next regularly scheduled meeting.

6.) Comments by Commissioners:

Chair C. Estrada informed everyone present at the meeting that she has been working on planting trees at various parks to provide shade for all the children who play and practice at those parks since currently they do not have any kind of shade. She advised that the goal is to plant 50 trees at the Andrade & 5th retention basin. As of right now they have already planted 30 trees they still need 20 trees. Each tree cost \$50.00. Chair C. Estrada invited everyone to attend a tree planting event the C-PAL is having on Saturday, May 16, 2015, at 8:00 a.m. at the 5th and Andrade and Daniel Gutierrez Fields.

Comm. K. Flores commented she wants to be realistic about the tree planting and maintaining of the trees after they are planted. She explained the City does not have the man power to take care of all these trees. Another idea could be to install tarps or shades of some sort. These items do not require constant watering or maintenance.

Comm. E. Marquez commented another idea could be to get children involved making the tree planting a fun project for them. Also get the community involved. Have the person or group that donated the tree be held responsible for the watering and maintenance of the tree.

Mr. Servin is to bring back the following items for the June 9, 2015, meeting: The Adopt-A-Highway Program information packet, a map of all entrances to the City and a list of businesses in Calexico.
