2. **Conditional Use Permit No. UA 2019-08 A&M Elite Commerce LLC DBA Headstash-** A Conditional Use Permit is sought to operate cannabis storefront retail, non-storefront retail with onsite consumption business. The property associated with this Conditional Use Permit application is located within the City’s Cannabis Overlay Zone at 551 State Highway 111, Calexico, CA. 92231 known as APN: 058-020-008. Each project associated with each Conditional Use Permit is exempt from formal environmental review pursuant to Section 15301, Existing Facilities of the CEQA Guidelines.

3. **UA 2019-21 Tentative Parcel Map No. 058-030-097** – The Tentative Parcel Map proposes the subdivision of approximately .36 acres in order to create two (2) parcels on land located north of the intersection of Estrada Boulevard and Camacho Road currently known as 308 Camacho Road Parcel 1 and Parcel 2 are both approximately .18 acres in size. This project is exempt from formal environmental review pursuant to Section 15315, Class 15 - Minor land divisions, of the CEQA Guidelines.
