2. UA2018- 18, Conditional Use Permit 2018-02 (I.V. Assisted Living). A Conditional Use Permit is being requested in order to allow the construction of a 67,000 s.f. assisted living facility on 4.25 acres of land located on the SW corner of

Robinson Avenue and Van de Graff Blvd. On-site parking for approximately 72 cars will be provided, 69 of which are regular stalls and 4 ADA, handicapped accessible stalls. The project site is further described as APN: 059-010-048.

The project is exempt from formal environmental review pursuant to Section 15332(a-d), infill development of the CEQA guidelines.


