2. UA2019- 05 Zoning Ordinance Amending Title 17, Chapter 17.05, 17.07, 17.11 Article X of the Calexico Municipal Code
 The proposed Zoning Ordinance Text Amendment would allow cannabis testing laboratories in certain commercial and industrial zones in addition to the Cannabis Overlay Zone where they are currently allowed. Cannabis testing laboratories test small samples of distinct traceable cannabis batches to determine potency, to analyze active compounds found in cannabis flowers, concentrates, and infused products, and to identify any microorganisms, pesticides, or residual solvents present in each sample. These types of testing methods are common in testing food products and pharmaceuticals.


