

RESOLUTION NO. 2018-11

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CALEXICO, CALIFORNIA, ESTABLISHING A FEE FOR THE REGISTRATION AND MAINTENANCE OF VACANT AND ABANDONED PROPERTY PURSUANT TO CHAPTER 8.50 OF THE CALEXICO MUNICIPAL CODE.

WHEREAS, in the last year, there has been an increased number of vacant, abandoned buildings associated with the increased number of foreclosures occurring as part of the housing downturn; and

WHEREAS, the City Council finds that the growing presence of vacant, abandoned buildings can discourage potential buyers from purchasing a property adjacent to or in neighborhoods with vacant, abandoned buildings; and

WHEREAS, the City Council finds that the increased number of these vacant and abandoned properties can lead to neighborhood decline and become attractive nuisances causing the City to incur significant costs in the form of the City staff time for code enforcement actions seeking to maintain the conditions of these properties; and

WHEREAS, the City Council finds that many vacant, abandoned buildings are the responsibility of out of area, out of state lenders and trustees; and

WHEREAS, in many instances these lenders and trustees fail to adequately maintain and secure these vacant buildings; and

WHEREAS, the City has an obligation to protect its neighborhoods from decline and devaluation; and

WHEREAS, prior to or concurrently with the adoption of this resolution, the City council has adopted Ordinance No. 1180 adding Chapter 8.50 to authorize the City to charge parties regarding the registration and maintenance of vacant and abandoned buildings; and

WHEREAS, it is the intention of the City Council that the fees herein shall cover, but not exceed, the estimated reasonable cost of providing the service for which the fee is charged; and

WHEREAS, based upon the evidence provided, the City Council hereby determines that the fees established herein reasonably cover, but do not exceed, the reasonable cost of providing the service for which the fee is charged.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Calexico, California, as follows:

Section 1. Fees. The following fees and charges are hereby established to recover the City's cost of providing municipal services to the public as follows:

A. Abandoned Property Registration Fee

This fee shall cover the City's costs to operate an abandoned property program which shall inspect abandoned buildings and/or issue notice of violations. A fee of \$150.00 per abandoned property shall be imposed with an annual re-newel fee of \$75.00.

B. Administrative Abatement Fee

This fee shall cover the City's costs incurred for staff administrative time, overhead cost, and related administrative cost to abate any existing nuisance conditions. A fee of \$ 400.00 per abatement action and any additional abatement action costs, including costs for contractors and legal fees, shall be imposed.

C. Monitoring Fee

This is a monthly monitoring fee of \$305.00 imposed in addition to a \$400.00 enforcement response fee for each time a building inspector is called to the vacant building site.

Section 2. Charges and Fees to over actual costs. In the event that the City incurs additional costs related to registering and maintaining a vacant and abandoned building, the City may charge the owner of said building additional charges and fees equal to the amount of actual costs incurred by the City. Such actual costs may include, but not be limited to, securing the building and other actual costs related to abating the nuisance created by abandoned and vacant buildings.




