

**Recommendation:**

Council to make the appointment of a Mayor Pro Tem.

**Discussion & Analysis:**

City Resolution 2013-34A sets the annual rotation of the Council in July of each year. Due to former Mayor Pro Tem Jesus Eduardo Escobar being elected on November 6, 2018 to represent District 1 as County Supervisor, his seat on the City Council was been vacated. Mr. Escobar tendered his resignation letter to the City Clerk on January 2, 2019 effective January 3, 2019.

As a result, and after an application process, the Council filled the position by appointment at the regular City Council meeting of February 6, 2019. However, the Mayor Pro Tem position continues to be vacant. The Council may now appoint a Mayor Pro Tem to serve in said position until the next annual rotation at the first meeting of July 2019.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CALEXICO ADOPTING AN AMENDED CITY COUNCIL ANNUAL ROTATION POLICY

WHEREAS, the City adopted a City Council Rotation Policy on December 20, 2011, which provides for the mayor and mayor pro tern seats to rotate annually at the first regular meeting in July; and

WHEREAS, on January 10, 2012 the City Council approved a change to the City's Municipal Election date from June to November.

WHEREAS, on March 6, 2012 the City Council adopted the Amended Council Policy regarding the Annual Rotation.


WHEREAS, it has been requested to change to the City's Rotation Policy date from December back to July beginning July 2013.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Calexico that the Amended City Council Policy dated March 6, 2012 be amended to rotate the Mayor and Mayor Pro Tern annually on the first regular meeting in July beginning July 2013.
