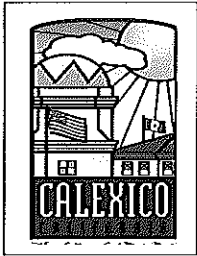

**Recommendation:**

The Planning division recommends that the City Council approve the following:

A Resolution Approving an Application for Funding and the Execution of a Grant Agreement and any Amendments thereto from the 2020 Community Development Block Grant Program-Coronavirus Response Round 2 and 3 (CDBG-CV2 and CV3) NOFA dated December 18, 2020

**Background:**

On December 18, 2020 the Department of Housing and Community Development (HCD) released the 2020 Community Development Block Grant Program- Coronavirus Response Round 2 and 3 (CDBG-CV2 and CV3 Notice of Funding Announcement (NOFA). The City Manager desires to apply for assistance funds from this program to mitigate the economic effects of the COVID-19 Pandemic on the City of Calexico in the amount of \$622,274 for use in Community Development and Economic Development. In addition, the City of Calexico applied for and was approved for funding under CDBG-CV1 grant for the creation of and dispersal of \$153,888 in December of 2020 and on March 15, 2021 the City was notified that the application was approved and moving towards the issuance of a Standard Agreement.

**A RESOLUTION APPROVING AN APPLICATION FOR FUNDING AND THE EXECUTION OF A GRANT AGREEMENT AND ANY AMENDMENTS THERETO FROM THE 2020 COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM- CORONAVIRUS RESPONSE ROUND 2 and 3 (CDBG-CV2 and CV3) NOFA DATED DECEMBER 18, 2020**

BE IT RESOLVED by the City Council of the City of Calexico as follows:

**SECTION 1:**

The City Council has reviewed and hereby approves the submission to the State of California of one or more application(s) in the aggregate amount, not to exceed, of \$622,247 for the following CDBG-CV2 and CV3 activities pursuant to the December 2020 CDBG-CV2/3 Notice of Funding Availability (NOFA):

**SECTION 2:**

The City of Calexico hereby approves the use of Program Income in an amount not to exceed \$ 0.00 for the CDBG-CV2 and CV3 activities described in Section 1.

**SECTION 3:**

The City of Calexico acknowledges compliance with all state and federal public participation requirements in the development of its application(s).

**SECTION 4:**

The City of Calexico hereby authorizes and directs the City Manager or designee\*, to execute and deliver all applications and act on the City of Calexico's behalf in all matters pertaining to all such applications.

**SECTION 5:**

If an application is approved, the City Manager or designee\*, is authorized to enter into, execute and deliver the grant agreement (*i.e.*, Standard Agreement) and any and all subsequent amendments thereto with the State of California for the purposes of the grant.

**SECTION 6:**

If an application is approved, the City Manager or designee, is authorized to sign and submit Funds Requests and all required reporting forms and other documentation as may be required by the State of California from time to time in connection with the grant.
