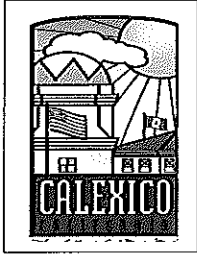

Recommendation:

Staff requests that the Council make one (1) appointment to the Sales Tax Citizen Advisory Committee (Measure H)

Background:

At the meeting of January 20, 2021, Mayor Arreola-Fernandez and Council Members made certain appointments to the Commissions, Boards and Committees pursuant to Section 2.19.010 of the Calexico Municipal Code. The appointment of a commissioner to the Sales Tax Citizen Advisory Committee (Measure H) was left pending due to the lack of applications.

Discussion & Analysis:

Pursuant to Municipal Code 2.19.010 - Appointments to commissions, boards and committees—Process.

A. Appointments to all city commissions, boards and committees, shall be made by the following process:

1. When the commission, board or committee consists of five members, each city council member will appoint one commissioner, board member or committee member. If after a reasonable amount of time (not to exceed forty-five days after an election is certified or vacancy otherwise exists), a city council member has failed to make an appointment, the appointment will be made by a majority vote of the city council and the appointee shall not be removed from office except by majority vote of the city council.
