

Recommendation:

Approve budget amendment resolution for Art in Public Places budget.

Background:

Art in Public Places is a fund that allows developers to pay a fee in lieu of installing art in new construction projects. This fund is for the city to do art installations that benefit the aesthetics of the community. The Calexico Mural Project is an example how the funds have been used.

The Calexico Mural Project is in its 7th cycle (about one cycle per year) of funding mural installations. For this cycle, a mural will be installed at the corner of 2nd Street and Cesar Chavez Boulevard. The installation will include a mural on the 84 ft wall, plus metal letters that spell CALEXICO on top of the wall and lighting. The project is part of the inauguration of the Cesar Chavez Blvd improvements. The ribbon cutting for this project will be on Tuesday, June 25, 2019.

Discussion & Analysis:

This budget amendment does not affect the General Fund. It will transfer money from the fund balance to cover the costs incurred by this mural project before June 30, 2019.

Fiscal Impact:


