

Recommendation:

Authorize City Manager to File Notice of Completion for Collapsed Sewer Pipeline at 600 Block of Lincoln Street.

Background:

On August 1, 2018, the City Council of the City of Calexico adopted a resolution pursuant to Public Contracts Code (PCC) Section 20168 finding that an emergency exists due to a collapsed sewer pipeline at the 600 block of Lincoln Street and authorized contracting without the need for bidding pursuant to PCC Section 22050 to A&R Construction in the amount of \$87,823.00.

Discussion & Analysis:

On August 24, 2018, A&R Construction completed the repair of the collapsed 8" sewer pipeline at the 600 block of Lincoln Street, therefore Public Works staff is recommending that the City Council of the City of Calexico authorize the City Manager to file Notice of Completion for said project.
