**Recommendation:**

Adopt Resolution No. 2025-61 Declaring a Local Emergency Related to the Severe Storm of September 18, 2025.

**Background:**

On Thursday, September 18, 2025, the City of Calexico experienced heavy rainfall and wind. The City Manager determined that circumstances of extreme peril to public safety were very severe. As a result, the City Manager declared a local emergency related to the impacts created by this storm.

**Discussion and Analysis:**

Calexico Municipal Code section 2.36.060(A)(1) empowers the City Manager, acting as the Director of Emergency Services, to proclaim the existence or threatened existence of a local emergency when the City is exposed to an actual or threatened existence of conditions of disaster or of extreme peril to the safety of persons and property within the City and the City Council is not in session.

The City Manager respectfully requests the city council to adopt a resolution of the City Council of the City of Calexico California declaring a local emergency related to the severe storm which occurred on September 18, 2025.

**RESOLUTION NO. 2025-61**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CALEXICO,  
CALIFORNIA DECLARING A LOCAL EMERGENCY RELATED TO  
THE SEVERE STORM OF SEPTEMBER 18, 2025**

**WHEREAS**, the City of Calexico is experiencing flooding, severe storm, beginning on September 18, 2025 which has caused and/or threatens to cause conditions of extreme peril to the safety of persons and property within the City of Calexico; and

**WHEREAS**, the City Council of the City of Calexico is empowered under Government Code Section 8630 and Calexico Municipal Code to proclaim the existence of a local emergency; and

**WHEREAS**, these conditions are beyond the control of the services, personnel, equipment, and facilities of the City of Calexico; and

**NOW, THEREFORE, IT IS HEREBY PROCLAIMED** by the City Manager of the City of Calexico that a local emergency exists in the City of Calexico, effective September 18, 2025 8:05 p.m.

**IT IS FURTHER PROCLAIMED AND ORDERED** that during the existence of said local emergency the powers, functions, and duties of the emergency organization of this City shall be those prescribed by state law, by ordinances and resolutions of this City, and by the City of Calexico Emergency Operations Plan.

**IT IS FURTHER ORDERED** that a copy of this resolution be forwarded to the Director of the Imperial County Office of Emergency Services, the Governor of the State of California, and the State Director of the Office of Emergencies.
