

Recommendation:

Authorize City Manager to File Notice of Completion for De Las Flores Street Improvement Federal Project No. CML-5168(030).

Background:

On September 19, 2018, the City of Calexico Public Works Department requested bids for De Las Flores Street Improvement Federal Project No. CML-5168(030). The project included grinding of existing asphalt concrete pavement, paving and surfacing, 8" sewer line, 6" waterline, fire hydrants, remove and replace concrete curb and gutter, traffic striping, utility adjustments and traffic control on De Las Flores Street between Kloke Avenue and Eady Avenue.

On October 25, 2018, the Office of the City Clerk received two (2) bids:

1 Pyramid Construction and Aggregate, Inc.	\$760,944.58
2 Granite Construction Company	\$889,629.00

On January 23, 2019, the City Council of the City of Calexico awarded Pyramid Construction and Aggregate, Inc. bid in the amount of \$760,944.58. Pyramid Construction and Aggregate, Inc. began to work on said project on March 4, 2019. Due to additional work that was not anticipated during the design phase of said project and construction quantities being over and under, the City Council of the City of Calexico authorized the City Manager to sign two (2) change orders. The total project amount is \$758,713.65.
