

SUBJECT: Approval of a Resolution Accepting Funding from the State of California Citizens' Option for Public Safety (Cops) Funds for Fiscal Years 2017/2018 and 2018/2019

Recommendation:

Recommend for the Calexico City Council's approval of additional funding and approval of the Resolution for State COPS.

Background:

For the past seventeen and a half (17 ½) years, the Calexico Police Department has received funding from the State of California Citizens' Option for Public Safety (COPS) program. The County of Imperial Administrative Staff has advised me that the Calexico Police Department has \$55,152.48 for FY 2017/2018 and \$100,000.00 for FY 2018/2019 available. The Calexico Police Department has not received these funds.

Discussion & Analysis:

Upon approval of the Resolution for acceptance of funds, a notification will be made to the Imperial County Administrative Office. These funds will provide salary/benefits, equipment, and training for a Police Officer and additional training and equipment needed for the Calexico Police Department.


