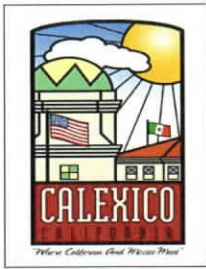

## Recommendation

Approve Resolution 2020-56 – A Resolution of the City Council of the City of Calexico California, Reciting the Fact of the General Municipal Election held on Tuesday, November 3, 2020 Declaring the Result and such other Matters as Provided by Law.

## Background:

On June 17, 2020, City Council approved Resolution No. 2020-37, Requesting the Board of Supervisors of the County of Imperial to conduct a General Municipal Election of the City of Calexico for:

Three Council Member seats (Four Year Term); and  
One Council Member seat (Two Year Term)

and render specified services to the City relating to the conduct of the election and to consolidate such election with any State or Local Election to be held on Tuesday, November 3, 2020. Pursuant to the resolution, the Registrar of Voters of the County of Imperial will canvass the returns of the election and certify the election results to the City Council of the City of Calexico.



**Discussion and Analysis**

This item is placed before the City Council to declare the election results of the November 3, 2020 General Municipal Election. The Imperial County Board of Supervisors certified the results of said election on December 3, 2020. The Council is required to adopt a resolution reciting the fact of the election and declaring the results and such other matters as provided by law.

## **RESOLUTION NO. 2020-56**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CALEXICO CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON TUESDAY, NOVEMBER 3, 2020 DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW.**

WHEREAS, a General Municipal Election was held and conducted in the City of Calexico, California on Tuesday, November 3, 2020 as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, pursuant to Resolution 2020-37, adopted on the 17<sup>th</sup> day of June, 2020, Requesting the Board of Supervisors of the County of Imperial to-render specified services to the City relating to the conduct of a General Municipal Election and to consolidate such election with any State or Local Election to be held on Tuesday, November 3, 2020.

WHEREAS, the County Election Department canvassed the returns of the elections and has certified the results to this City Council, the results are received, attached and made a part hereof as Exhibits 1 and 2; and

WHEREAS, that pursuant to the provisions of Section 10403 of the Elections Code of the State of California, this City Council requested the Board of Supervisors of the County to permit the County Election Department to conduct the election of the City of Calexico according to State law, on Tuesday, November 3, 2020, to submit the following to the voters:

### **THREE SEATS ON THE CITY COUNCIL (4 YEAR TERMS)**

### **ONE SEAT ON THE CITY COUNCIL (2 YEAR TERM)**

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CALEXICO, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:**

**SECTION 1.** The City Clerk shall enter on the records of the City Council of the City of Calexico, a statement of the result of the election, showing:
