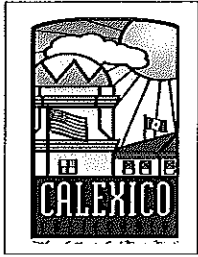

Authorize City Manager to File Notice of Completion for 2nd Street, Dool Avenue and Beach Avenue Water Pipeline Replacement Project.

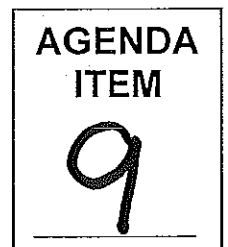
Background:

On March 2, 2020, the City of Calexico Public Works Department requested bids for 2nd Street, Dool Avenue and Beach Avenue Water Pipeline Replacement Project. The project consisted of the installation of a new 8 inch diameter water main pipeline along 2nd Street from Blair Avenue to Andrade Avenue. The project also included the installation of 8 inch diameter water main pipelines along Dool Avenue and Beach Avenue between 2nd Street and 7th Street. The project also included connecting existing water services and fire hydrants to the new water main pipelines.

On June 3, 2020, the City Council of the City of Calexico awarded a construction agreement with A&R Construction in the amount of \$1,274,501.75 for 2nd Street, Dool Avenue and Beach Avenue Water Pipeline Replacement Project. Due to additional work that was not anticipated during the design phase of said project, the City Council of the City of Calexico authorized the City Manager to sign one (1) change order. The total project amount is \$1,298,861.20.

Discussion & Analysis:

On May 25, 2021, A&R Construction completed 2nd Street, Dool Avenue and Beach Avenue Water Pipeline Replacement Project, therefore Public Works staff is recommending that the City Council of the City of Calexico authorize the City Manager to file Notice of Completion for said project.
