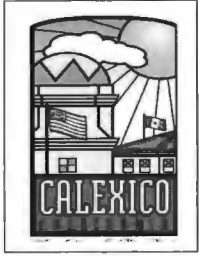

SUBJECT: Approve Purchase of Equipment for New Police Vehicles

Recommendation

It is recommended that the City Council of the City of Calexico approve the following:

1. Authorize City Manager to Purchase Equipment for Eight (8) Marked Police Patrol Vehicles for the Calexico Police Department.

Background:

The Calexico Police Department was granted permission by the City Council to purchase Eight (8) Police Patrol Vehicles on October 6, 2021, with the American Rescue Plan Act (ARPA) Federal Grant.

Discussion and Analysis

The Calexico Police received a quote from Airwave Communications for a total of \$220,996.80 to outfit the Eight (8) Marked Police Patrol Vehicles. Airwave Communications is the Sole Source Provider. The Sole Source Justification Form for this purchase is attached. The funding of this purchase would come out of the City of Calexico's American Rescue Plan Act (ARPA). This expenditure was previously approved Council as Item #14 on October 6, 2021, Calexico City Council Meeting. Funding allocated is \$604,000.00 for Police. The Cost for the vehicles is \$407,928.43 with the remainder of \$196,071.57. Total cost for the equipment is \$220,996.80.

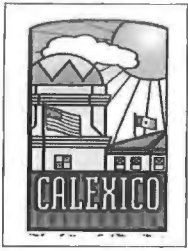

Recommendation:

Adopt Resolution No. _____ of the City Council of the City of Calexico accepting and appropriating unanticipated revenue in the amount of \$9,526,987 from the American Rescue Plan Act (ARPA) State and Local Fiscal Recovery Funds, Federal Emergency Management Administration (FEMA), California Governor's Office of Emergency Services (CalOES) in the Fiscal Year 2021-22 Budget as outline in the attached resolution.

Background:

The U.S. Treasury Department released final allocation amounts and interim guidance on the use of ARPA funding. The final allocated amount to the City of Calexico is \$9,526,987. A fact sheet from the U.S. Treasury on the State and Local Fiscal Recovery Funds from the ARPA is attached.

Discussion & Analysis:

Staff estimates that all funds received from ARPA will be obligated and or expend by December 31, 2026 on eligible uses as specified below:

1. Respond to the COVID-19 public health emergency and support various activities to decrease the spread of the virus;
2. Address negative economic impacts caused by the public health emergency;

3. Replace lost public sector revenue due to the pandemic
4. Provide premium pay to eligible workers or grants to eligible employers of essential workers; and
5. Invest in water, sewer, and broadband infrastructure.

Through September 2021, the City has submitted to FEMA \$90,000 in eligible claims, pending CDR review and \$140,000 are pending submission. The City received \$504,948 through the State Controller's Office the Coronavirus Relief Funds. City Administration is developing an expenditure plan for American Rescue Plan Act (ARPA) funds.

On September 16, 2021, the City Manager and Finance Director presented a proposal on how the funds should be used for the Public Safety Fleet. The Proposal is as follows:

Fire Department:

- Two Fire Rescue Ambulances – Estimated Cost \$187,000 per unit.
- Three Fire Utility Vehicles – Estimated Cost \$100,000 per unit
- Estimated Total Cost \$674,000.

Police Department:

- Six Ford Explorer Fully Equipped Patrol Vehicles – Estimated Cost \$73,000 per unit
- Two Pickup Truck Fully Equipped Patrol Vehicles – Estimated Cost \$83,000 per unit.
- Estimated Total Cost \$604,000.

City Administration is also requesting authorization to develop and publish a Request for Proposals (RFP) for items listed above.

Fiscal Impact: None currently since the funding will come from ARPA funds.

1. Invitation for Bid/Bid Rejection/Waiver of Informalities

This invitation for bid includes an invitation for both Purchase Bid and Lease-Purchase Bid options. The Police Department, in its sole discretion, will determine whether a Purchase Bid or Lease-Purchase Bid is in the best interest of the City.

THE CITY RESERVES THE RIGHT TO REJECT ANY OR ALL BIDS OR ANY PART THEREOF, TO WAIVE ANY INFORMALITIES IN THE BID AND MINOR IRREGULARITIES, TECHNICAL DEFECTS OR CLERICAL ERRORS.

The City's decision shall be final. The City's waiver of an immaterial defect shall in no way modify the bid documents or excuse the bidder from full compliance with its specifications if the bidder is awarded the bid.

2. Condition of Equipment Bid

If equipment is proposed, it is to be the newest and latest model in current production. Used, re-manufactured, shopworn, demonstrator, prototype or discontinued models are not acceptable unless otherwise stipulated under this bid.

3. Brand Names

For this BID only FORD Explorers, FORD F-150 Police Responder, FORD Expedition, FORD F-250 will be considered.

4. Payments, Invoicing and W-9 Certification Form

The successful bidder may also request changes in the bid, but no work will be performed on such changes until the request is approved in writing by the City. Such changes shall be performed in accordance with the original bid requirements except as modified by an amendment. Except as herein provided, the successful bidder shall have no claim for any other compensation due to changes in the work.

Any changes or deviation from the contract made without authority in writing from the Calexico Police Department will be at the bidder's own risk. 14. Qualification of Bidder

15. Default

Prices paid by the

City must be considered the prevailing market price at the time such purchase is made. These rights and remedies shall not be exclusive but in addition to any other rights and remedies provided by contract law. Periods of performance may be extended if the facts as to the cause of delay justify such extension in the opinion of the City.

16. Cancellation of Purchase Order and/or Contract

18. Nondiscrimination

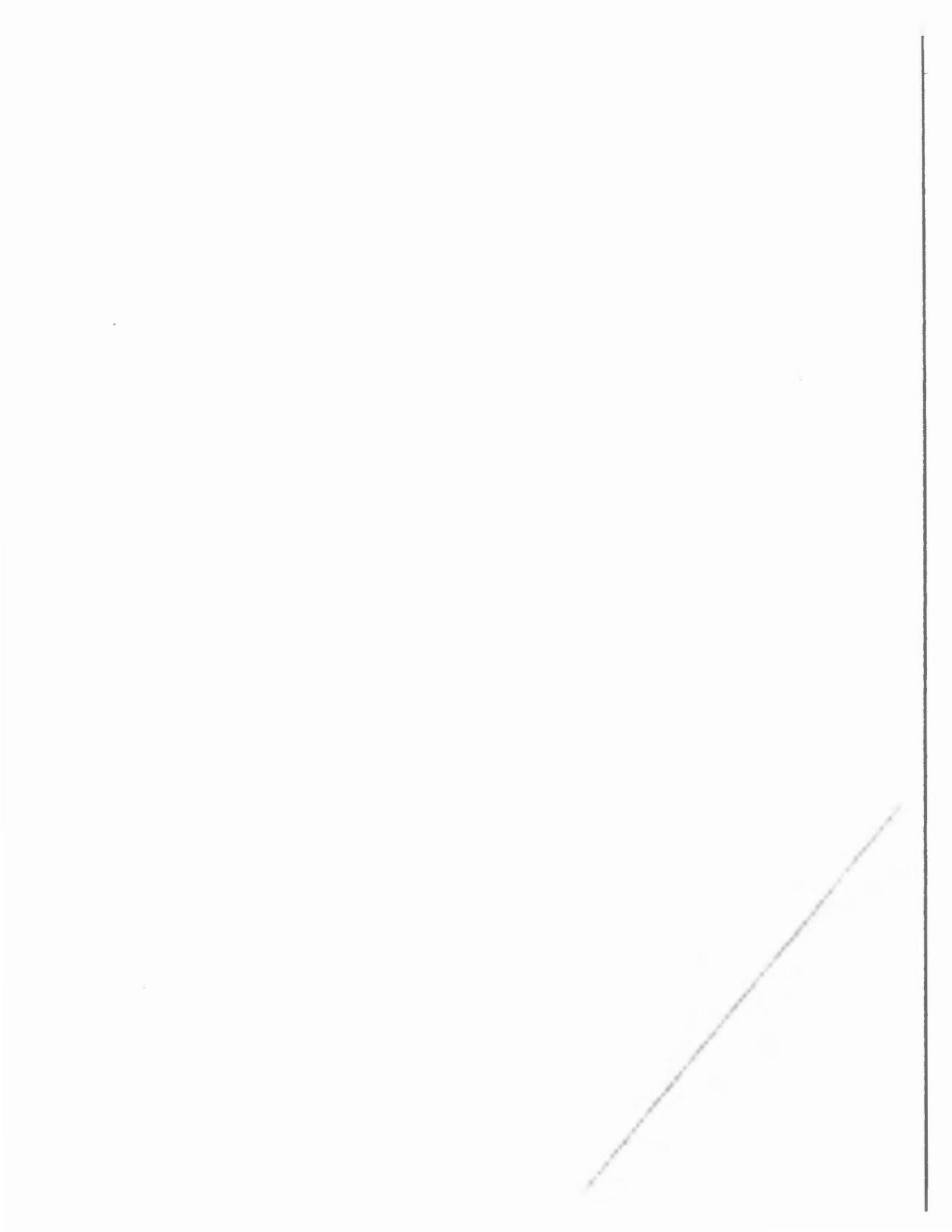




