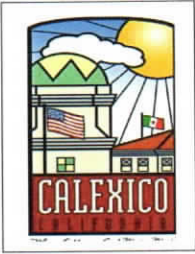

Planning and Building Services Director Tylanda provided a report on the public Convenience and Necessity certification for bus routes within Calexico City limits for application from Abelardo Perez, Numero Uno Shuttle. Ms. Tylanda answered questions from the Council concerning bus fares and transportation needs. Council discussed the current bus rates, transportation coverage and needs for bus service.

Police Chief Gerardo advised one of the items required is for the company first go to California Highway Patrol and then to Calexico Police Department for inspections.

Applicant Abelardo Perez commented on bus fares and explained the need to increase the bus fare to \$3.00 to offset the costs of providing the service. Mr. Perez requested Council consideration and approval for the needed transportation in Calexico.

Luis Castro addressed the Council and state he understood the need for transportation and high costs associated with providing bus service to the community.

Applicant Abelardo Perez requested council consideration for two routes for his buses..

Ben Horton spoke on the costs for the businesses to provide the service and spoke in favor of Mr. Perez being granted the certificates to provide the service.

City Manager Figueroa requested consideration for approval of the resolution presented before the Council.

Motion was made by Council Member Ureña, seconded by Mayor Pro Tem Garcia to approve the resolution for the Application for Public Convenience and Necessity Certification for Bus Transit Route within Calexico City Limits. Motion passed by a unanimous roll-call vote.
