

Background:

On February 18, 2021, the City of Calexico submitted a grant application, GEN-21-12527. to the California Arts Council for funding under their Arts and Cultural Organizations General Operating Relief 2021 Grant Program. On September 2, 2021, the City of Calexico received an award letter from the California Arts Council in the amount of \$19,000.00.

On March 9, 2022, the City of Calexico submitted a grant application, GEN-22-17278, to the California Arts Council for funding under their Arts and Cultural Organizations General Operating Relief 2022 Grant Program. On May 17, 2022, the City of Calexico received an award letter from the California Arts Council in the

amount of \$28,500.00.

Discussion & Analysis:

GEN-21-12527 gran activity period was scheduled for October 1, 2021 – September 30,2022. However, due to administrative delays caused by the COVID-19 Pandemic, activity period was revised to November 1, 2021 – October 31, 2022. Funds became available in February 2022 after the City finally received the California Arts Council's check for the GEN-21-12527 award. Final grant report is due on November 30, 2022.

GEN-22-17278 gran activity period was originally scheduled for July 1, 2022 – June 2023; however, it was later revised to September 1, 2022 – August 31, 2023. Final grant report will be due on September 30, 2023.

The scope of work is for the City of Calexico to utilize funding from GEN-21-12527 and GEN-22-17278 for eligible expenses related to general operations of the Carmen Durazo Cultural Arts Center.

For this reason, City staff is recommending that the City Council adopt a resolution of the City of Calexico ratifying the submittal of the Arts and Cultural Organizations General Operating Relief 2021 Grant Application in the amount of \$19,000.00 and the 2022 Grant Application in the amount of \$28,500.00 and authorizing the City Manager to executive agreements and/or any documentation pertaining to the California Arts Council Arts and Cultural Organizations General Operating Relief Grant.

Recommendation:

Approval of \$800.00 Sponsorship for Christmas Dance event to be held on December 9, 2022.

Background:

On October 28, 2022, Recreation hosted its first indoor dance since the COVID-19 pandemic. With over one hundred and fifty guests, the event was not only a success, but it also was an event that our senior citizen community was looking forward to.

On November 2, 2022, the City Council of the City of Calexico met in a regular meeting in which Councilman Garcia and Councilwoman Arreola-Fernandez expressed an interest to sponsor four hundred dollars each (\$400.00) from their discretionary funds for the Recreation Department to organize a Christmas Dance.

Discussion & Analysis:

Councilman Garcia and Councilwoman Arreola-Fernandez recommend a donation of four hundred dollars each (\$400.00) from their discretionary funds. If approved, the City would be sponsoring a grand total of eight hundred dollars (\$800.00) for the aforementioned event.
