### **BASIC FUNCTION:**

Under the direction of the Supervisor-Maintenance & Operations, paint street lines, warnings and curb markings; paint, repair, install and maintain a variety of street signs.

### **REPRESENTATIVE DUTIES:**

#### **ESSENTIAL DUTIES:**

Paint street lines, warnings and curb markings; utilize paint brushes or painting machines to paint, center and side traffic lines, cross walks, loading zones, bus stops, parking lines, handicap zones and other street lines; maintain safe markings for drivers and pedestrians on City streets and sidewalks.

Lay out various street lines and zones; prepare surfaces for painting; set up and arrange traffic barricades and cones as needed.

Install, maintain and repair traffic regulatory, warning, guide, construction, advertising, street name, bus stop and other street signs.

Operate a paint truck, paint and line striper machines, spray guns, sweepers and a variety of hand tools; clean and maintain assigned equipment; drive a vehicle to conduct work.

Communicate with other City departments and outside agencies to coordinate activities, resolve issues and exchange information.

Maintain working areas and equipment in a safe, clean and orderly condition.

Maintain routine records related to assigned activities.

#### **OTHER DUTIES:**

Perform routine carpentry duties related to the construction and repair of street barricades and similar wooden structures as needed.

Perform general construction and maintenance work on a variety of public works projects as assigned including repairing sidewalks and trimming trees.

Train and provide work direction to assistants as assigned.

Perform related duties as assigned.

**KNOWLEDGE AND ABILITIES:**

**KNOWLEDGE OF:**

Methods, tools, equipment and supplies utilized in painting pavement surfaces.

Materials and techniques utilized in installing and maintaining a variety of traffic and regulatory signs.

Operation of a paint truck, paint and line striper machines, spray guns, sweepers and a variety of hand tools.

Appropriate safety precautions and procedures.

Oral and written communication skills.

Health and safety regulations.

Traffic laws, defensive driving techniques and rules of the road.

Basic record-keeping techniques.

**ABILITY TO:**

Paint street lines, warnings and curb markings.

Paint, repair, install and maintain a variety of street signs.

Utilize paint brushes or painting machines to paint, center and side traffic lines, cross walks, loading zones, bus stops, parking lines, handicap zones and other street lines.

Learn applicable laws, codes, rules and regulations related to assigned activities.

Work safely and efficiently under traffic conditions.

Maintain working areas and equipment in a safe, clean and orderly condition.

Operate a variety of painting equipment.

Understand and follow oral and written instructions.

Communicate effectively both orally and in writing.

Work cooperatively with others.

Meet schedules and time lines.

**EDUCATION AND EXPERIENCE:**

Any combination equivalent to: graduation from high school and two years of painting experience.

**LICENSES AND OTHER REQUIREMENTS:**

Valid California driver's license.

**WORKING CONDITIONS:**

**ENVIRONMENT:**

Outdoor and shop environment.

Driving a vehicle to conduct work.

Seasonal heat and cold or adverse weather conditions.

Regular exposure to paint fumes.

**PHYSICAL DEMANDS:**

Dexterity of hands and fingers to operate painting equipment and tools.  
Seeing to mix and match paint colors.  
Standing for extended periods of time.  
Lifting, carrying, pushing or pulling heavy objects as assigned by the position.  
Reaching overhead, above the shoulders and horizontally.  
Bending at the waist, kneeling or crouching.

**HAZARDS:**

Regular exposure to fumes from paints and solvents.  
Traffic hazards.
